**RESPONSE TO APPLICATION BY**  
**NORMAN L. GILBREATH AND LORETTA E. GILBREATH**

Norman L. Gilbreath and Loretta E. Gilbreath respond to the Application by Energen Resources Corporation for an order amending compulsory Order No. R-10154, which pooled all interests in the Fruitland Coal Formation (Basin-Fruitland Coal Gas Pool (71629) underlying the S/2 of Section 19, Township 30 North, Range 11 West, N.M.P.M., San Juan County, New Mexico, as follows:

1. Energen Resources Corporation is the current operator of the Flora Vista 19 No. 1 Well and the Flora Vista 19 No. 2 Well that were drilled and completed in the Fruitland Coal Formation.

2. The S/2 of Section 19, Township 30 North, Range 11 West, N.M.P.M., San Juan County, New Mexico is dedicated to these two Flora Vista Wells.

3. Order No. R-10154 was issued by the New Mexico Oil Conservation Division ("NMOCD") on July 19, 1994, which Order compulsory pooled certain uncommitted interests in the S/2 of Section 19, Township 30 North, Range 11 West, N.M.P.M., San Juan County, New Mexico prior to the drilling of the Flora Vista 19 No. 1 Well.

4. Our oil and gas interests in the Fruitland Coal Formation underlying the SE/4 of Section 19, Township 30 North, Range 11 West, N.M.P.M., San Juan County, New Mexico were compulsory pooled by Order No. R-10154.

5. Our oil and gas interests that were compulsory pooled by Order No. R-10154 comprised approximately 48.60% (158.56 acres/326.26 acres) of the working interests in the Fruitland Coal Formation underlying the S/2 of Section 19, Township 30 North, Range 11 West, N.M.P.M., San Juan County, New Mexico.

6. One of our oil and gas leases that was compulsory pooled in the SE/4 of Section 19, Township 30 North, Range 11 West, N.M.P.M., San Juan County, New Mexico was an Oil and Gas Lease dated August 4, 1972 between Frank A. King and Paula S. King, husband and wife, "Lessors", and Rodney P. Calvin, "Lessee" ("King Lease").

7. The King Lease contains 18.37 acres and comprises approximately 5.63% (18.37 acres/326.26 acres) of the total working interests in the S/2 of Section 19, Township 30 North, Range 11 West, N.M.P.M., San Juan County, New Mexico.

8. Frank A. King and Paula S. Elmore formerly known as ("f.k.a."). Paula S. King have recently alleged that the King Lease has terminated, and they filed a law suit September, 2013 in the United States District Court for the District of New Mexico in a law suit entitled "Frank A. King and Paula S. Elmore f/k/a Paula S. King vs. Norman L. Gilbreath et al., No. 1:13-cv-00862-RHS-LAM, seeking, among other claims, the termination of the King Lease.

9. We obviously deny the claims and allegations that have been made in the above-described law suit.

10. The subject Application filed by Energen Resources Corporation requesting an order amending compulsory Order No. R-10154 has been prematurely filed as there has not been a final judicial determination the King Lease has been forfeited, canceled or terminated in the above-described law suit.

11. However, we have no objection if the NMOCD desires to issue an amendment to Order No. R-10154 that retroactively compulsory pools the oil and gas interests of Frank A. King and Paula S. Elmore f.k.a. Paula S. King in the unlikely event the United States District Court enters a final judicial determination that that the King Lease has been forfeited, canceled or terminated.


