2 EXAMINER GOETZE: At this point in time, we  
3 will start off with Case 15063, application of COG  
4 Operating, LLC for a nonstandard spacing and proration  
5 unit and compulsory pooling, Lea County, New Mexico,  
6 consolidated with Case 15064, which is application of  
7 COG Operating, LLC for a nonstandard spacing and  
8 proration unit and compulsory pooling, Lea County,  
9 New Mexico.

10 Call for appearances.

11 MR. FELDEWERT: Mr. Examiner, Michael  
12 Feldewert, with the Santa Fe office of Holland & Hart,  
13 appearing on behalf of the Applicant, COG Operating,  
14 LLC.

15 EXAMINER GOETZE: Mr. Bruce?

16 MR. BRUCE: Mr. Examiner, I think I entered  
17 an appearance for Kaiser-Francis Oil Company who is not  
18 opposing the case.

19 EXAMINER GOETZE: Correct, you did.

20 MR. BRUCE: We're just interested parties.

21 EXAMINER GOETZE: Very good.

22 MR. FELDEWERT: Mr. Examiner, you may  
23 recall with these cases, we seek to create two 160-acre  
24 nonstandard spacing units in the east half of Section  
25 18, Township 24 South, Range 34 East. We seek to then

1 pool the Bone Spring Formation underlying this acreage.  
2 These cases were consolidated for hearing at the last  
3 docket, December 19th, 2013, and at that time you heard  
4 the testimony from the landman and the geologist. And  
5 the Division accepted ten exhibits at that time.

6 The cases were then continued to allow  
7 timely notice to two additional parties. One was the  
8 New Mexico Department of Transportation, which owns less  
9 than two percent of the subject acreage. And as the  
10 landman testified, the company has been unable to reach  
11 a lease with this state agency.

12 The other individual was June Cook. She  
13 owns less than one percent of the interest in the  
14 acreage, as the landman also testified at the last  
15 hearing. We had given her notice by publication, but  
16 then we had located an address.

17 And so we'd asked that the case be  
18 continued to allow timely notice to both the Department  
19 of Transportation and for Ms. June Cook.

20 As reflected in Exhibit Number 11, which  
21 I've handed to you this morning, timely notice has now  
22 been provided both to the New Mexico Department of  
23 Transportation and to Ms. June Cook. So we ask that  
24 Exhibit Number 11 be admitted into the record and that  
25 you take these consolidated cases under advisement.

1 EXAMINER GOETZE: Very good. Exhibit  
2 Number 11 is accepted, and Case 15063 and Case 15064 are  
3 taken under advisement.

4 (COG Operating, LLC Exhibit Number 11 was  
5 offered and admitted into evidence.)


