3 the meeting of the New Mexico Oil Conservation
4 Commission on Thursday, February 13th, at Porter Hall.

5 To my right is Terry Warnell, who is the
6 designee of the Commissioner of Public Lands.

7 To my left is Dr. Robert Balch, who is the
8 designee of the Secretary of Energy, Minerals and
9 Natural Resources Department.

10 I am Jami Bailey, Director of the Oil
11 Conservation Division.

12 So we have all three commissioners here.
13 We have a quorum.

14 Commissioners, have you had a chance to
15 look at the minutes of the last meeting that we held,
16 which was November 21st, 2013?
