- 1. CASE 15104: Application of Premier Oil & Gas, Inc. for compulsory pooling, Eddy County, New Mexico. Applicant in the above-styled cause seeks an order (1) dedicating the E/2 of Section 22, Township 26 South, Range 27 East, NMPM, Eddy County, New Mexico, to a standard 320-acre gas spacing and proration; and (2) pooling all mineral interests in the Wolfcamp formation underlying this acreage. Said standard unit is to be dedicated to applicant's proposed Owl Draw 22 BO Federal Com. No. 1H, which will be horizontally drilled from a surface location in the NW/4 NE/4 (Unit B) and to a bottom hole location in the SW/4 SE/4 (Unit O) of Section 22. Also to be considered will be the cost of drilling and completing said well and the allocation of the cost thereof as well as actual operating costs and charges for supervision, designation of Premier Oil & Gas, Inc. as operator of the well and a 200% charge for risk involved in drilling said well. Said area is located approximately 12 miles southeast of Black River Village, New Mexico.
- 2. <u>CASE 15105</u>: Application of COG Operating LLC for a non-standard spacing and proration unit and compulsory pooling, Lea County, New Mexico. Applicant seeks an order from the Division: (1) creating a non-standard 240-acre, more or less, oil spacing and proration unit in the Bone Spring formation, comprised of the E/2 SE/4 of Section 6 and the E/2 E/2 of Section 7, Township 19 South, Range 35 East, NMPM, Lea County, New Mexico; and (2) pooling all mineral interests in the Bone Spring formation underlying this proposed non-standard spacing and proration unit. This proposed non-standard spacing and proration unit will be the project area for the Airstrip Fee Com. Well No. 1H. The completed interval for this well will be within the 330-foot standard offset required by the rules. Also to be considered will be the cost of drilling and completing said well, the allocation of these costs as well as the actual operating costs and charges for supervision, designation of COG Operating LLC as operator of the well, and a 200% charge for risk involved in drilling said well. Said area is located approximately 23 miles west of Hobbs, New Mexico.
