




Ladies and gentlemen:



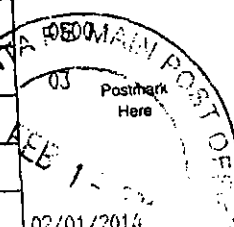
