In reference to the above, please execute the enclosed extra sets of signature pages of the Communitization Agreement and return same to me at your earliest convenience.


For your information, the captioned well was recently completed as a horizontal oil well producing from the Second Bone Spring Sand interval in the Bone Spring formation.


