Dear Mr. Brooks,

This is a follow up to the telephone message I left you yesterday (Friday 5/5/06) following a meeting I had with Mr. Tim Gum and Mr. Van Barton in the Artesia office of the Oil Conservation Division.

The Artesia office was under the mistaken impression that this was an orphaned well and that we were not going to take care of our responsibilities in the plugging or to bring the well into compliance for temporary abandonment and/or recompletion. I assured both Mr. Gum and Mr. Barton that we would file the necessary paperwork and perform the necessary work to bring the well into compliance. Work has been underway with investors and other operators to attempt a recompletion in a up hole zone. In these times a well bore in this area and this depth is far to valuable to permanently abandon. The well could be tested immediately for Temporary Abandonment if not for the packer being 309' above the existing Wolfcamp perforations. Therefore we will have to obtain a workover unit to place a plug within 100' of existing perforations. As we are all aware it will take some time to obtain a workover unit. I will get on a waiting list for the first available unit and keep the Artesia office posted.

Both Mr. Gum and Mr. Barton suggested that I contact you and get this Case 13715 removed from the upcoming hearing and give me time to file necessary paper work to bring the well into compliance.

Please advise me that this case has been removed from the Thursday, May 11, 2006 Docket hearing. Thank you for you time and consideration in this matter.
