Dear Jim:

We have been advised that you are representing Read & Stevens with reference to the captioned order, which was a part of the Inactive Well Program.

Our records indicate that Read & Stevens has still not plugged 3 of the 9 wells that it was ordered to plug and has not paid the \$26,000 civil penalty. Also, 12 additional wells have now gone inactive, as shown on the attaché print-out. We would like to secure compliance with the order.

Read & Stevens has objected that they did not receive notice of the order within thirty days of its issuance, and therefore were precluded for pursuing an appeal to the Commission. That is probably accurate inasmuch as no appearance was entered on their behalf at the Division hearing. If you decide to contest this order, it can now be done only by a motion to reopen. In the absence of such a motion, we would appreciate being advised when we can expect compliance, including payment of the civil penalty.
