Dear Mr. Perrin,

In response to your letter dated April 11, 2002, please find attached an update. We are still working to meet your deadline, however as we discussed earlier this year, we may not be completed and would hope that you would work with us to obtain a common goal of all wells being in compliance. We still have a lot of work to do due to the notice of violation, which had to be addressed. It is also necessary to keep the active wells producing to develop cash flow to work on the inactive wells. It is our intent to get as much work done as possible between now and June 1.

Your original letter dated September 15, 2000 included 43 wells being in non-compliance. In December 2000 we submitted a plan of action of which we have placed 16 wells back on production, plugged 3 wells for the state and 8 wells for the BLM, for a total of 27 wells being placed back into compliance.

Your letter dated April 11, 2002 included 33 wells of which only 23 wells were included in the September 15, 2000 memo. Ten additional wells were included of which 1 well was placed back on production and witnessed by your office and supported by the C-103. We are moving forward with the remaining wells.

Please bear with me. We will cooperate with you and your staff to get the project completed.
