This letter is to advise you that DCP Midstream LP ("DCP") filed a C-108 application on March 24, 2014, with the New Mexico Oil Conservation Commission seeking authorization to drill a redundant Acid Gas Injection (AGI) well at their Artesia Plant (the "Plant") in Lea County, New Mexico. The plant has had an AGI well operating since 2002 and this is an additional proposed well to be used in conjunction with the existing well. The proposed well is a deviated well to be located in Section 7 Township 18 South, Range 28 East, NMPM, Lea County, New Mexico. DCP plans to inject up to 2 million standard cubic feet per day (MMSCFD) of treated acid gas from the Plant at a maximum pressure of 1704 psi into this well in the Lower San Andres, Glorieta and Upper Yeso, approximately 3,600 to 4,300 feet below the surface. The proposed well will serve as a disposal well for acid gas at the Artesia plant. While the AGI is primarily expected to inject only acid gas, the design and requested approval would also allow for the safe injection of approximately 600 barrels per day of wastewater from the plant.

This application (Case Number 15127) has been set for hearing before the New Mexico Oil Conservation Commission at 9:00am on May 22, 2014, in Porter Hall at the New Mexico Oil Conservation Division's Santa Fe office located at 1220 South Saint Francis Drive, Santa Fe, New Mexico 87505. You are not required to attend this hearing, but as an owner of an interest that may be affected by DCP's application, you may appear and present testimony. Failure to appear at that time and become a party of record will preclude you from challenging the application at a later date.

A party appearing at the hearing is required by Division Rule 19.15.4.13 NMAC to file a Pre-Hearing Statement at least four days in advance of a scheduled hearing, but in no event not later than 5:00 p.m. Mountain Time on the Thursday preceding the scheduled hearing date. This statement must be filed at the Division's Santa Fe office at the above-specified address and should include the names of the parties and their attorneys; a concise statement of the case; the names of all witnesses the party will call to testify at the hearing; the approximate time the party will need to present its case; and an identification of any procedural matters that need to be resolved prior to the hearing.
