3 the meeting of the Oil Conservation Commission on  
4 Thursday, June 19th, in Porter Hall, in Santa Fe,  
5 New Mexico.

6 To my right is designee of the Commissioner  
7 of Public Lands, Terry Warnell. That came out  
8 backwards. To my right is Terry Warnell, who is the  
9 designee of the Commissioner of Public Lands,

10 To my left is Dr. Robert Balch, who is  
11 designee of the Secretary of Energy, Minerals and  
12 Natural Resources Department.

13 And I am Jami Bailey, Director of the Oil  
14 Conservation Division.

15 So we have all three commissioners. We  
16 have a quorum today.

17 Commissioners, have you had a chance to  
18 read the minutes of our meeting on May 22nd.

19 COMMISSIONER WARNELL: Yes, I have.

20 COMMISSIONER BALCH: And I have.

21 CHAIRPERSON BAILEY: Do I hear a motion to  
22 sign them on behalf of the Commission?

23 COMMISSIONER WARNELL: I make that motion.

24 COMMISSIONER BALCH: And I second it.

25 CHAIRPERSON BAILEY: All those in favor?

2 CHAIRPERSON BAILEY: I will sign them and  
3 transfer them to the Commission secretary.

4 The first order of business, let's continue  
5 a couple of cases that are on the docket, Case Number  
6 15044, which is the application of COG Operating, LLC  
7 for a nonstandard spacing and proration unit and  
8 compulsory pooling in Lea County, New Mexico, and also  
9 Case 15035, which is the application of COG Operating,  
10 LLC for two nonstandard project areas, two nonstandard  
11 oil spacing and proration units and approval of  
12 nonstandard locations for two wells in Lea County,  
13 New Mexico. Both of these cases have been continued to  
14 the July 17th docket.
