21 15146, application of Devon Energy Production Company,
22 L.P. for a nonstandard oil spacing and proration unit
23 and compulsory pooling, Eddy County, New Mexico. And
24 the cases were consolidated, and I've got two of them,
25 each for one.

1 MR. BRUCE: Two notice affidavits. Exhibit
 2 11 is actually for Case 15145, and Exhibit 12 is for
 3 Case 15146. Again, this was a deceased -- or two
 4 deceased record title owners being force pooled only for
 5 communitization purposes. Charles Jones and his wife
 6 Sadie Jones died decades ago, but they're still record
 7 title owners in the federal records. And I would move
 8 the admission of Exhibits 11 and 12.

 10 be admitted.


