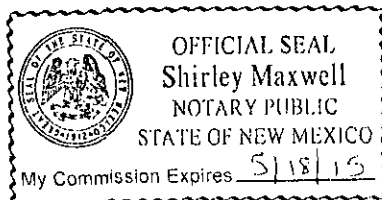

Division seeking an order
approving a 160-acre non-
standard oil spacing and
proration unit (project

formation comprised of
the S/2N/2 of Section 24,

County, New Mexico. Ap-
plicant further seeks the
