**APPLICANT'S STATEMENT OF CASE**

EOG seeks an order (1) creating a 160-acre spacing and proration unit comprised of the E/2 E/2 of Section 21, Township 26 South, Range 33 East, NMPM, Lea County, New Mexico and (2) pooling all mineral interests in the Bone Spring formation. This non-standard unit is to be dedicated to applicant's proposed **Thor 21 1H Well** to be horizontally drilled from a surface location in the SE/4 SE/4 (Unit P) to a standard

bottom hole location in the NE/4 NE/4 (Unit A) of Section 21. The completed interval for this well will remain within the 330-foot standard offset required by the rules.


