Mickey, I received your fax regarding your mother's estate. It appears that the Trust created U/W/O both of your parents has terminated upon your mother's death. Accordingly all properties were devised equally to the three children. John O. Steinman owned a 0.006055% leasehold interest below the top of the Bone Spring formation in Section 17, T20S, R29E, Eddy Co., NM. We have formed a one Section Working Interest Unit (WIU) covering all of Section 17 whereby we are drilling multiple horizontal wells for Bone Spring oil production. Since the Steinman interest is divided 3 ways, each of you own a .001092% leasehold interest in Section 17 as to this WIU. We have plans to immediately drill the Glock "17" LI Federal #1H Well in the N/2S/2 of Section 17. The estimated well cost for this well is \$4,856,600.00.
