- 1. My name is Joseph Scott and I am employed by COG Operating, LLC, in Midland, Texas, as a Landman. I have previously testified before the Division and have been qualified as an expert in petroleum land matters.
- 2. Division Order R-13659 created a 160-acre non-standard spacing and proration unit in the Glorieta-Yeso formation (Atoka-Glorieta-Yeso Pool (3250)) consisting of the E/2 E/2 of Section 8, Township 19 South, Range 26 East, NMPM, Eddy County, New Mexico and pooled the uncommitted mineral interest in this spacing and proration unit. This unit was dedicated to COG's proposed **Bradley 8 Fee Well No. 4H** (API No. 30-015-39813). This well has not yet been drilled by COG and is subject to an approved extension of time to commence drilling until December 15, 2014.
- 3. Since the entry of Order R-14919, COG has discovered additional mineral interest owners in the Unit that were not notified and pooled under Case No. 14919.
- 4. COG has undertaken efforts to locate and obtain a voluntary agreement for the development of these lands from these additional mineral interest owners in the Unit, some of which are not locatable or currently have unmarketable title.
