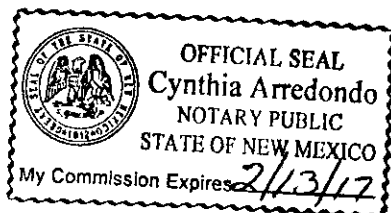

Applicant further seeks the pooling of all mineral interests in the Bone Spring formation underlying the W/2W/2 of Section 35 to form a non-standard 160 acre oil spacing and proration unit (project area), for all pools or formations developed on 40 or 80 acre spacing within that vertical extent. The unit is to be dedicated to the Layla 35 B2MD Fee Well No. 3H, a horizontal well with a surface location in the SW/4SW/4, and a terminus in the NW/4NW/4, of Section 35. Also to be considered will be the cost of drilling and completing the well and the allocation of the cost thereof, as well as actual operating costs and charges for supervision, designation of applicant as operator of the well, and a 200% charge for the risk involved in drilling and completing the well. The application is scheduled to be heard at 8:15 a.m. on Thursday, July

10, 2014 at the Division's offices at 1220 South St. Francis Drive, Santa Fe, New Mexico 87505.
