APPLICANT'S STATEMENT OF CASE

Applicant seeks an order (1) pooling all mineral interests in the Wolfcamp formation, South Culebra Bluff – Wolfcamp Gas Pool, underlying the S/2 of Section 14, Township 24 South, Range 28 East, and (2) authorizing an unorthodox well location. Matador proposes to dedicate the S/2 of Section 14 to its proposed **Tiger 14-24S-28E RB #224H Well**, which will be horizontally drilled from a surface location 350 feet from the South line and 250 feet from the East line (Unit P) to a bottom hole location 350 feet from the South line and 260 feet from the West line (Unit M) of Section 14. This acreage is subject to the statewide rules for gas pools

which requires 320-acre spacing and wells to be located no closer than 660 feet to the outer boundary of the spacing unit. The proposed **Tiger 14-24S-28E RB #224H Well** will be unorthodox because the completed interval for this well will be closer than 660 feet to the spacing and proration units to the South, Southeast and Southwest.




