

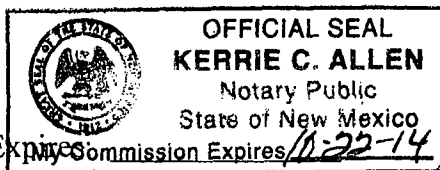
James Bruce, being duly sworn upon his oath, deposes and states:


Ladies and gentlemen:

The Pre-Hearing Statement must also be provided to the undersigned.


