APPLICATION

Mewbourne Oil Company applies for an order (i) approving a non-standard oil spacing and proration unit in the Bone Spring formation comprised of the N½S½ of Section 27, Township 18 South, Range 30 East, N.M.P.M., Eddy County, New Mexico, and (ii) pooling all mineral interests in the Bone Spring formation underlying the non-standard unit, and in support thereof, states:

- 1. Applicant is an interest owner in the N½S½ of Section 27, and has the right to drill a well thereon.
- 2. Applicant is drilling its Ursa 27 B2LI Fed. Com. Well No. 1H to a depth sufficient to test the Bone Spring formation. Applicant seeks to dedicate the N½S½ of Section 27 to the well to form a non-standard 160 acre oil spacing and proration unit (project area) in the Bone Spring formation for all pools developed on 40 acre spacing. The well is a horizontal well, with a surface location in the NW¼SW¼ of adjoining Section 26, and a terminus in the NW¼SW¼ of Section 27.
- 3. Applicant has in good faith sought to obtain the voluntary joinder of all other mineral interest owners in the N½S½ of Section 27 for the purposes set forth herein.
- 4. Although applicant attempted to obtain voluntary agreements from all mineral interest owners to participate in the drilling of the well or to otherwise commit their interests to the well, certain interest owners have failed or refused to join in dedicating their interests.
