- 3. CASE 15224: Application of Sovereign Eagle, LLC for Compulsory Pooling, Roosevelt County, New Mexico.
 Applicant seeks an order consolidating each of the 40-acre, 160-acre, and 320-acre spacing units within the N/2 of Section 26, Township 2 South, Range 29 East, NMPM. Roosevelt County, New Mexico as follows: the SE/4 NW/4 for all formations developed on a 40-acre basis; the NW/4 for all formations developed on a 320-acre basis, including but not limited to the Montoya formation, Tule-Montoya Gas Pool (86442).
