1. I am over the age of 18, and have personal knowledge of the matters stated herein.

2. I am a geologist for Legend Natural Gas III, LP ("Legend"), and I am familiar with the geological matters involved in this case

3. In this case Legend seeks to expand the North Hay Hollow-Bone Spring Pool (the "Pool") so that it includes the following acreage:

Township 25 South, Range 27 East, N.M.P.M.Section 22:AllSection 23:AllSection 24:AllSection 25:AllSection 26:E/2

Township 25 South, Range 28 East, N.M.P.M. Section 7: E/2Section 8: All Section 17: W/2 Section 18: All Section 19: All Section 20: W/2 Section 29: W/2 Section 30: All

The pool currently covers only the NE/4 of Section 26, Township 25 South, Range 27 East, N.M.P.M., but has been expanded by the Division's Hobbs District Office due to additional wells drilled in the area of the original pool.

4. The geological plats attached hereto as Attachment 1 show the following:

Page 1 is a structure map on top of the Second Bone Spring sand, which is the (a)primary productive interval of horizontal wells in the Pool. It shows regional east dip with no structural elements impacting continuity of the reservoir across the proposed Pool expansion.

Page 2 is a gross isopach of the Second Bone Spring sand. It shows that there are **(b)** no major thickness changes or stratigraphic elements impacting continuity of the reservoir across the proposed Pool expansion.

5. I conclude from the plats that the Bone Spring formation is continuous across the Pool's boundaries, and that all acreage described in paragraph 3 above should be included in the Pool.


