The subject well name should be North Brushy Draw Federal Com 35-4H.

The proposed producing formation is the Wolfcamp, with a TVD of 10,440' and BHL of 600 feet FNL/1,980 feet from the West line.

To accommodate the change in formation and BHL, the drilling plan proposes a 7 inch intermediate casing string be run to KOP, a 6 1/8 inch production interval be drilled, and a 5 1/2 inch by 4 1/2 inch tapered longstring be run.
