APPLICATION

Apache Corporation ("Apache") applies for an order pooling all mineral interests from the surface to the base of the Abo formation underlying the SW/4NW/4 of Section 2, Township 20 South, Range 38 East, NMPM, Lea County, New Mexico, and in support hereof, states:

- 1. Apache (OGRID 873) is a working interest owner in the SW/4NW/4 of Section 2, Township 20 South, Range 38 East, and has the right to drill a well thereon.
- 2. Applicant proposes to drill its Pinot #005 Well, at an orthodox location, to a depth sufficient to test the Abo formation, and seeks to dedicate the SW/4NW/4 of Section 2, Township 20 South, Range 38 East, to form a standard 40 acre oil spacing and proration unit for any formations and/or pools developed on 40 acre spacing within that vertical extent.
- 3. Applicant has in good faith sought to obtain the voluntary joinder of all other mineral interest owners in the SW/4NW/4 of Section 2, Township 20 South, Range 38 East, for the purposes set forth herein.
- 4. Although applicant attempted to obtain voluntary agreements from all mineral interest owners to participate in the drilling of the well or to otherwise commit their interest to the well, certain interest owners have failed or refused to join in dedicating their interests.

Therefore, applicant seeks an order pooling all mineral interest owners in the SW/4NW/4 of Section 2, Township 20 South, Range 38 East, pursuant to NMSA 1978 §70-2-17.

5. The pooling of all mineral interests underlying the SW/4NW/4 of Section 2, Township 20 South, Range 38 East, will prevent the drilling of unnecessary wells, prevent waste, and protect correlative rights.

WHEREFORE, applicant requests that, after notice and hearing, the Division enter its order:

- A. Pooling all mineral interest in the SW/4NW/4 of Section 2, Township 20 South,

 Range 38 East, from the surface to the base of the Abo formation;
- B. Designating applicant as operator of the well;
- C. Considering the cost of drilling and completing the well, and allocating the cost among the well's working interest owners;
- D. Approving actual operating charges and costs for supervision, together with a provision adjusting the rates pursuant to the COPAS accounting procedures; and
- E. Setting a 200% charge for the risk involved in drilling and completing the well in the event a working interest owner elects not to participate in the drilling of the well.


