**VERIFIED STATEMENT OF ROBERT B. WILSON**

**Robert B. Wilson**, being duly sworn upon his oath, deposes and states:

1. I am a landman for RMR Operating, LLC ("RMR"), and have personal knowledge of the matters stated herein.

2. I have the following educational experience and work experience in the oil and gas business: I hold Bachelor of Arts and Juris Doctorate degrees. I have over 8 years of working experience as a staff landman with publicly traded companies in the oil and gas industry. Former employers include Chesapeake Energy Corporation (1 year) and XTO Energy Inc. (5 years). I am currently employed by RMR and manage its Land Department (2+ years). Experience includes working federal, state, BIA, and fee properties in Texas, Louisiana, New Mexico, Oklahoma, Kansas, Colorado, and Montana.

3. Pursuant to NMAC 19.15.4.12.A(1), the following information is submitted in support of the compulsory pooling application filed herein:

(a) The purpose of this application is to force pool record title owners in a federal lease for purposes of obtaining Bureau of Land Management ("BLM") approval of a communitization agreement.

(b) No opposition is expected because the interest owners being pooled are deceased.

(c) RMR seeks an order approving a 234.75-acre non-standard oil spacing and proration unit (project area) in the Delaware formation comprised of the W/2E/2 of Section 25, and Lot 2 and the NW/4NE/4 of Section 36, Township 26 South, Range 34 East, NMPM. Applicant further seeks the pooling of all mineral interests in the Delaware formation underlying the non-standard oil spacing and proration unit (project area) for all pools or formations developed on 40 acre spacing within that vertical extent. The unit will be dedicated to the Madera 25 Fed. Com. Well No. 2H, a horizontal well with a surface location in the NW/4NE/4 of Section 25, and a terminus in Lot 2 of Section 36. Also to be considered will be the designation of applicant as operator of the well. A Sundry Notice with a Form C-102 for the well is attached hereto as Exhibit A.

The beginning of the producing interval is: Top Packer at 8,866' MD from the North and East lines of Section 25 (521.6' FNL of Section 25, 2,069.3' FEL of Section 25) and Bottom Hole Location at 15,827' MD from South and East lines of Section 36 (337' FSL Section 36, 2,038' FEL Section 36).

(d) The parties being pooled are the following record title owners in Federal Lease NM 65441, which includes all of Section 25:

(e) Because these persons are deceased, no request was made to them to sign the communitization agreement.

(f) RMR has made a good faith effort to locate the record title owners.

(g) Because the record title owners own no working interest, no risk charge or overhead charges are requested.

(h) The only offset operator to the well is RMR.

(i) RMR requests that it be designated operator of the well.

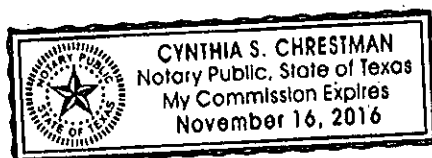

3. Run 9 5/8" 40# L-80 LT & C to 5,325' ( Base of Larmar Lime)

4. Drill 8 3/4" pilot hole to 9, 350', Log interval from 9,350 to 5,325 with GRNDL and DLL-MSFL, continue GRNL to surface.

5. Spot cement plug from TD 9350' to 8,300' ( See attached cmt program)

(7" casing, deep intermediate will be removed from program)

6. Drill 8 3/4" curve KOP 8,477' MD to TVD 9,050' drill 8 3/4" lateral to total measured depth 15,815' with TVD 9,050'.

7. Run new 5 1/2" 17# HCP 110 GBCD open hole completion system with a hydraulic set cmt stage tool in the curve 8550' and a mechanical cmt stage tool set at 5700'. ( See attached cement program and openhole completion program)

The 5 1/2" casing has a collapse design factor 2.18, Internal yield Factor 2.28, Tension design factor 3.55. The casing will be set 150' off bottom 15665' for the first completion stage of the 27 stage system. The 5 1/2" casing will be ran the complete length of the well.
