Good afternoon, Phillip.

BTA submitted an application to convert our 8036 JV-P Brian #1 to disposal in May 2014. There was a protest by Limestone Livestock, LLC, but we worked it out with them and the protest was withdrawn. The Commissioner of Public Lands requested an advance royalty payment for estimated loss of revenue and that was paid by BTA.

The hearing for the application held on August 21, 2014 went smoothly. The only additional request has been from the NMOCD requesting information that BTA is not causing waste of the remaining Atoka reserves. Our attorney drafted a response and we received the draft, for our review, in February 2015.

As we discussed on the phone this date, we are currently evaluating our project(s). We would like to request that the application be held under consideration. We will advise of our intent to move forward, as soon as the decision is made.
