Hello Ms. Lockett;

Looks like these injection wells were all permitted under R-8140-A in Case No. 8840.

The Pool is the South Lucky Lake Queen Pool - See R-4435 for Special Pool Rules.

I just looked and since injection was not reported for any of these wells during 2014, therefore under Rule 26, this waterflood project is no longer permitted – R-8140-A has gone away.

**Please confirm this with Maxey Brown or Paul Kautz of the Hobbs OCD.**

The Federal-State-Fee Unit was setup only for purposes of waterflooding, so that Unit should also terminate if the waterflood is no longer.

The status of this South Lucky Lake Queen Unit should be clarified with the BLM in Roswell and the State Land Office in Santa Fe before Tandem comes back to hearing to re-instate the waterflood.


