STATEMENT OF CASE

APPLICANT:

Applicant in the above-styled cause seeks an order approving a non-standard oil spacing and proration unit in the Wolfcamp formation and pooling of all uncommitted mineral interests in the Wolfcamp formation underlying the S/2 of Section 13, Township 24 South, Range 28 East, NMPM, Eddy County, New Mexico.

Matador seeks an order from the Division: (1) creating a 320-acre, more or less, non-standard gas spacing and proration unit ("project area") in the Wolfcamp formation comprised of S/2 of Section 13, Township 24 South, Range 28 East, NMPM, Eddy County, New Mexico; (2) pooling all mineral interests in the Wolfcamp formation underlying this non-standard spacing and proration unit/project area; and (3) approving a non-standard location.

This proposed non-standard spacing and proration unit will be the project area for the Janie Conner 13-24S-28E RB #224H well, to be horizontally drilled. Also to be considered will be the cost of drilling and completing said well, the allocation of these costs as well as the actual operating costs and charges for supervision, designation of Matador as operator of the well, and a 200% charge for risk involved in drilling said well. Said area is located approximately 17 miles southeast of Carlsbad, New Mexico.


