AFFIDAVIT OF NOTICE

I hereby certify that notice of this proposed rulemaking was given as follows:

1. The Oil Conservation Division filed the application in rulemaking case 13564 on September 2, 2005. In accordance with 19.15.14.1202.A(1) NMAC, notice was provided to the Albuquerque Journal, a newspaper of general circulation in the state, for publication more than 20 days prior to the scheduled hearing date of October 13, 2005. Exhibit A, attached, is a copy of the notice, with the cover letter that was sent to the Albuquerque Journal on September 2, 1005. Exhibit B, attached, is a copy of proof sheet returned by the Albuquerque Journal, indicating a publication date of September 8, 2005. The Oil Conservation Division has not received an affidavit of publication from the Albuquerque Journal, but will supplement the record when it receives the affidavit.

2. Notice was placed on the October 13, 2005 Oil Conservation Commission hearing docket, and the docket was sent by regular or electronic mail to all who have requested such notice on September 26, 2005. Rule 19.15.14.1202.A(2) NMAC (Rule 1202.A(2))requires that the docket be mailed by the Commission Clerk to all who have requested such notice not less than 20 days prior to the hearing. Notice should have been sent on Friday, September 23, 2005; instead it was sent on Monday, September 26, 2005. See Exhibit C, attached. The Division has filed a motion for an order shortening the time for notice under Rule 1202.A(2), so that the notice provided by the Commission Clerk will be recognized as timely.

3. Notice was published in the New Mexico Register on September 15, 2005, more than 10 days prior to the scheduled hearing date, as required by Rule 19.15.14.1202(3) NMAC. See Exhibit D, attached.

4. Notice was posted on the Oil Conservation Division's website on September 7, 2005, not less than 20 days prior to the scheduled hearing date, as required by Rule 19.15.14.1202.A(4) NMAC. See Exhibit E, attached.


