Administrative Order NSP-1796

Dear Messrs. Morgan and Mainord:

Reference is made to the application filed by SDX Resources, Inc. by letter dated July 6, 1998 requesting authorization to divide the existing 120-acre non-standard gas spacing and proration unit ("GPU") in the Jalmat Gas Pool that currently comprises the E/2 NE/4 and the NE/4 SE/4 of Section 32, Township 24 South, Range 37 East, NMPM, Lea County, New Mexico, into two separate GPU's comprising 80 acres and 40 acres.

The existing 120-acre GPU was authorized by Division Order No. R-488, issued in Case No. 718 dated July 7, 1954, and had dedicated thereon the E. G. Rodman operated State "L" Well No. 1 (API No. 30-025-11312), located at a standard gas well location 3300 feet from the North line (1980 feet from the South line) and 660 feet from the East line (Unit ~~H~~) of Section 32. This well was renamed the Humble "L" State Well No. 3 in 1965 and is now owned and operated by M-T Petroleum, Inc.

It is our understanding that:

- (1) SDX Resources, Inc. recently drilled and completed its Enco State Well No. 1 (API No. ~~30-025-24057~~³⁴⁰⁵⁷) at a standard gas well location 660 feet from the North and East lines (Unit A) of Section 32 within the Jalmat Gas Pool and that the 40 acres comprising the NE/4 SE/4 of Section 32 is to be dedicated to this well; furthermore,
- (2) the remaining 80 acres comprising the E/2 NE/4 of Section 32 is to be dedicated to the above-described M-T Petroleum, Inc. Humble "L" State Well No. 3.

The subject application of SDX Resources, Inc. has been duly filed under the provisions of Rule 104.F of the General Rules and Regulations of the New Mexico Oil Conservation Division ("Division") and Rule 2(d) of the "*General Rules for the Prorated Gas Pools of New Mexico/Special Rules and Regulations for the Jalmat Gas Pool*", as promulgated by Division Order No. R-8170, as amended. Pursuant to said rules no objection to the subject application has been received within the required 20-day waiting period. The two above-described non-standard GPU's in Section 32 are hereby approved with allowables to be assigned thereto in accordance with Rule 5 of the special Jalmat Gas Pool rules based upon their respective unit sizes.

Division Order No. R-488 shall be placed in abeyance until further notice.

Jurisdiction of this case is retained for the entry of such further orders as the Division may deem necessary.

Administrative Order NSP-1796

Dear Messrs. Morgan and Mainord:

Due to inadvertence the descriptions of the two authorized 80-acre and 40-acre non-standard gas spacing and proration units within the Jalmat Gas Pool approved by Division Administrative Order NSP-1796, dated October 14, 1998, were incorrect and the two numbered sub-paragraphs under the statement "*It is our understanding that*" on page one of this order shall be amended at this time to read as follows:

"(1) SDX Resources, Inc. recently drilled and completed its Enco State Well No. 1 (API No. ~~30-025-24057~~) at a standard gas well location 660 feet from the North and East lines (Unit A) of Section 32 within the Jalmat Gas Pool and that the 80 acres comprising the E/2 NE/4 of Section 32 is to be dedicated to this well; furthermore,

(2) the remaining 40 acres comprising the NE/4 SE/4 of Section 32 is to be dedicated to the above-described M-T Petroleum, Inc. Humble "L" State Well No. 3."

Further, all other provisions of said order shall remain in full force and effect until further notice.
