EXAMINER STOGNER: At this time I'm going to call Case Number 13,081, which is the Application of David H. Arrington Oil and Gas, Inc., for compulsory pooling, Lea County, New Mexico.

Call for appearances.

MR. CARR: May it please the Examiner, my name is William F. Carr with the Santa Fe office of Holland and Hart, L.L.P. We represent David H. Arrington Oil and Gas, Inc., in this matter, and I have a statement.

EXAMINER STOGNER: Please continue.

MR. CARR: Mr. Examiner, the acreage that is the subject of this case in the west-half equivalent of Irregular Section 31, Township 15 South, Range 36 East, was the subject of Case 12,752. An order was entered in that case, Order 11,690, on November the 16th, 2001, pooling the acreage and granting the application of Mr. Arrington.

Mr. Arrington obtained an extension of the pooling order once from the Division, and there were questions about whether or not they were going to go forward with this well. They now have determined that they want to go forward and drill the Royal Stimulator 31 Well Number 2 to a depth sufficient to test the Morrow.
