STATEMENT OF CASE

Applicant in the above-styled cause seeks authorization to simultaneously dedicate the standard 160-acre gas spacing unit in Rhodes formation, Rhodes Yates-Seven Rivers Gas Pool, comprised of the NE/4 of Section 9, Township 26 South, Range 37 East, NMPM, to the following three wells:

- A. Rhodes Federal Unit Well No. 98 located in Unit B at an ~~un~~orthodox well location 660 feet from the North line and 1650 feet from the East line;
- B. Rhodes Federal Unit Well No. 95 (API No. 30-025-24524) located in Unit G at an ~~no~~ standard gas well location 1980 feet from the North line and 2180 feet from the East line; and

- C. Rhodes Federal Unit Well No. 96 (API No. 30-025-24536) located in Unit H at a standard gas well location 1980 feet from the North line and 760 feet from the East line.


