CASE 7971: (Continued from October 26, 1983, Examiner Hearing)

(This Case will be continued to the November 22 Examiner Hearing)

Application of Tenneco Oil Company for compulsory pooling, San Juan County, New Mexico. Applicant, in the above-styled cause, seeks an order pooling all mineral interests in the Dakota and Mesaverde formations underlying the E/2 of Section 2, Township 30 North, Range 11 West, to be dedicated to a well to be drilled at a standard location thereon. Also to be considered will be the cost of drilling and completing said well and the allocation of the cost thereof as well as actual operating costs and charges for supervision, designation of applicant as operator of the well and a charge for risk involved in drilling said well. Applicant further seeks an order reducing an overriding royalty burden.

CASE 7993: Application of Harvey E. Yates Company for salt water disposal, Eddy County, New Mexico.

Applicant, in the above-styled cause, seeks authority to dispose of produced salt water into the Strawn and Morrow formations in the perforated intervals from 10,501 feet to 10,577 feet in the Strawn formation and 11,276 feet to 11,333 feet and 11,401 feet to 11,411 feet in the Morrow formation in its Stebbins Deep Federal Well No. 1 located 1980 feet from the North line and 990 feet from the East line of Section 30, Township 20 South, Range 29 East.

CASE 7994: Application of Phillips Petroleum Company for a waterflood project, Lea County, New Mexico.

Applicant, in the above-styled cause, seeks authority to institute a waterflood project in the Maljamar Grayburg-San Andres Pool, by the injection of water into the perforated interval from 4,146 feet to 4,422 feet in its Mexco-A Well No. 2 located 1980 feet from the South line and 660 feet from the East line of Section 2, Township 17 South, Range 32 East, and injection of water into the perforated interval from 4,465 feet to 4750 feet in its Wyatt A Federal Well No. 4 located 1650 feet from the North and West lines of Section 33, Township 17 South, Range 33 East.

CASE 7995: Application of Coastal Oil & Gas Corporation for an unorthodox oil well location, Lea County, New Mexico.

Applicant, in the above-styled cause, seeks approval of an unorthodox oil well location 660 feet from the South line and 1340 feet from the East line of Section 22, Township 14 South, Range 32 East, Tulk-Pennsylvanian Field, the SE/4 of said Section 22 to be dedicated to the well.

CASE 7996: Application of Stevens Operating Corporation for compulsory pooling, Chaves County, New Mexico.

Applicant, in the above-styled cause, seeks an order pooling all mineral interests from the surface to the base of the Abo formation underlying the SE/4 of Section 35, Township 6 South, Range 22 East, to be dedicated to a well to be drilled at a standard location thereon. Also to be considered will be the cost of drilling and completing said well and the allocation of the cost thereof as well as actual operating costs and charges for supervision, designation of applicant as operator of the well and a charge for risk involved in drilling said well.

Application of Bliss Petroleum, Inc. for the rescission of Order No. R-2789, Lea County, New Mexico. Applicant, in the above-styled cause, seeks the rescission of Order No. R-2789 which approved the South Penrose Skelly Unit.

CASE 7997: Application of Gulf Oil Exploration and Production Company for an unorthodox oil well location, Lea County, New Mexico. Applicant, in the above-styled cause, seeks approval of an unorthodox oil well location 461 feet from the North line and 1880 feet from the East line of Section 16, Township 19 South, Range 35 East, Scharb-Bone Spring Pool, the N/2 NE/4 of said Section 16 to be dedicated to the well.
