4. <u>Case No. 15402</u>: Application of COG Operating LLC for a non-standard spacing and proration unit and compulsory pooling, Eddy County, New Mexico. Applicant in the above-styled cause seeks an order (1) creating a non-standard. 160-acre, more or less, spacing and proration unit comprised of the E/2 W/2 of Section 29, Township 25 South, Range 27 East, NMPM, Eddy County and (2) pooling all mineral interests in the Bone Spring formation underlying this acreage. Said non-standard unit is to be dedicated to applicant's proposed Populus Federal No. 3H Well, which will be horizontally drilled from a surface location in the SE/4 SW/4 (Unit N) of Section 20 to a standard bottom hole location in the SE/4 SW/4 (Unit N) of Section 29.
