XTO Energy Inc. hereby proposes the drilling of an approximate 8,460' TVD and 16,500' TMD well to test the 3rd Bone Spring formation at a surface location of 200' FSL and 800' FEL of Section 6, T25S-R29E and a bottom hole location of 2,440' FSL and 330' FEL of Section 31, T24S-29E, Eddy County, New Mexico. The proposed proration unit for this well is the E/2E/2 of Section 6, T25S-29E and E/2SE/4 of Section 31, T24S-29E, Eddy County plat is included for your review.

The approximate cost to drill this test is \$1,989,000.00 with a completion cost of \$5,110,000.00 as evidenced on the enclosed Authority for Expenditure (AFE). Should you wish to participate with your interest, please sign the enclosed AFE and return to the undersigned.
