Permian TDS seeks authority to utilize the Canadian Kenwood Fed. No. 1 Well (API No. 30-015-23068) located in the SE/4 SW/4 (Unit N) of Section 17, T-18-S, R-31-E, for disposal of produced water into the San Andres and Delaware formations via "open hole" at depths of 4512 feet to 5700 feet. Devon Energy owns oil and gas development rights in this area that will be negatively impacted by the proposed disposal well.




