5           CHAIRMAN FESMIRE: The next cause before the  
6 Commission is Case Number 13,274, the Application of Arch  
7 Petroleum, Inc., for approval of two nonstandard gas  
8 spacing and proration units in the Jalmat Gas Pool in Lea  
9 County, New Mexico.

10           I understand that at the request of the attorneys  
11 this case is to be continued to the October 13th, 2005,  
12 meeting. Unless there's objection to the Commissioners,  
13 that case will be continued.

14           COMMISSIONER CHAVEZ: No objection.

15           COMMISSIONER BAILEY: No objection.

16           CHAIRMAN FESMIRE: The next is Case Number  
17 13,504. It's a de novo Application of Apache Corporation  
18 for statutory unitization in Lea County, New Mexico.

19           I understand that the petitioner has asked that  
20 that case be dismissed and that an order has been drafted  
21 to that effect; is that correct?

22           MS. DAVIDSON: Yes.

23           CHAIRMAN FESMIRE: Is there any opposition from  
24 the Commission to continuing that case -- I mean to

6 COMMISSIONER BAILEY: I so move.

7 COMMISSIONER CHAVEZ: Second.

8 CHAIRMAN FESMIRE: All those in favor?

9 COMMISSIONER BAILEY: Aye.

10 COMMISSIONER CHAVEZ: Aye.

11 CHAIRMAN FESMIRE: Opposed?

12 Let the record reflect that the Commission has  
13 voted to dismiss the case, and the order will now be signed  
14 by the Commissioners.

15 The last case on the docket is Case Number  
16 13,486, *de novo* Application of Synergy Operating, L.L.C.,  
17 for compulsory pooling in San Juan County, New Mexico.

18 And also I understand that at the request of the  
19 attorneys in this case that this case will be continued, is  
20 that -- they've asked that this case be continued?

21 MS. DAVIDSON: Yes, they have.

22 CHAIRMAN FESMIRE: Is there any opposition from  
23 the Commission?

24 COMMISSIONER BAILEY: No.


