You are hereby notified that at 8:15 AM on September 17, 2015, the New Mexico Oil Conservation Division (OCD) will hold a hearing seeking an order against Dominion Production Company, LLC, finding that the operator is in violation of Agreed Compliance Order 285, the oil and gas act, NMSA 1978, Sections 70-2-1 et seq. and OCD rules, NMAC 19.15.2 et seq., requiring operator to return to compliance with division rules by a date certain, and in the event of non-compliance, request for additional sanctions. The hearing will be held in Porter Hall at 1220 South St. Francis Dr., Santa Fe, New Mexico.

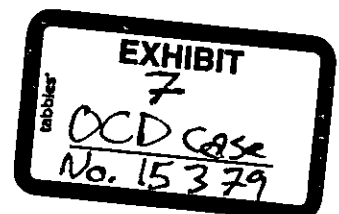
