All prehearing statements, according to Rule	
24 1211, should be filed by 5:00 p.m. on Thursday before the	
25 next scheduled hearing. 5:00 p.m. If you come by at 5:01	,

1	it's late. And what do we do with late prehearing
2	statements? Here, as you see on your docket, it says
3	either to be continued or dismissed. Well, I'm now going
4	to be drastic. This is what we're going to do.
5	If your prehearing statement is late, that case
6	will be continued automatically. I mean, from today on, it
7	will be continued.
8	If you don't file prehearing statements at all,
9	the case will be dismissed without prejudice, which means
10	you can go ahead and start all over.
11	So this is just to help us, you know, get a
12	handle on this. I think it will help everyone in this
13	case.
14	Now you might ask, if a case is contested or
15	somebody's contesting that case also file a prehearing
16	statement on that deadline. If the person fails to file a
17	prehearing statement, well, the case may be continued or
18	heard on the discretion of the Applicant. If the Applicant
19	wants the case to go forward, if he has met all the
20	requirements of this caption on our docket, filed his
21	prehearing statement and is ready to go and says, Well
22	the Examiner, We're not going to continue this case, we're
23	going to hear the case, yes, we are going to hear the case,
24	even though the opposing party didn't submit any prehearing
25	statement.

1 However, the opposing party may not -- may be barred from calling witnesses, unless the applicant has no 2 opposition to that. If the applicant says, Oh, I don't 3 care, he can call his witness, well, we allow that. But if 4 he says, I don't know about this witness and therefore I'm 5 not going to call that, then we -- it will be barred. 6 7 So for both the applicant and somebody who is also opposing the application have to file their prehearing 8 statements on that deadline. 9 Let's try and meet -- This is a simple 10 requirement. I think there is a reason why this rule is 11 written here. If you submit your prehearing statement by 12 5:01 on a Thursday -- I don't know what -- your case. 13 Or if you don't submit it, what are you thinking? If you 14 don't submit a prehearing statement and you tell -- you fly 15 16 over from New York to come and hear a case that you're not 17 interested in, I don't care whether the rig is moving out, 18 we -- that case will be dismissed without prejudice, which 19 means you go and start all over, do, you know, notice requirements and go through all the formalities again. 20 21 I think that's fair. 22 So if you have a docket and you think you are 23 going to hear the case, give us a prehearing statement. 24 However, I have a lot of cases here that says --25 they gave me the prehearing statement on time, and later

they reach an agreement, and then they said, Okay, dismiss 1 case. One of them came in, the prehearing statement was 2 ready to go, and now you say, Okay, I want the case 3 continued or dismissed. You can do whatever you want, 4 provided you have met the requirement of filing by 5:00 5 p.m. on that Thursday. Then you can come in on Friday and 6 7 say, Well, this case should be dismissed because we reached an agreement, or this case will be continued. Even today, 8 you can say this case should be continued or dismissed, 9 whatever you want. 10 But if you don't meet all the requirements that 11 are stated in this caption here, whether you want the case 12 13 to be heard, it will be continued or dismissed under those criteria. 14 15 Does anybody have any comments on this?

Because from today I'm going to hear any case that doesn't have any prehearing statement, which I have a couple of them here. I'm going to hear them, I don't care. I will do it today, but that is the end of it now. I've been saying this all over.

So for next time, don't think we will give you that privilege again. If you want to hear the case, it's a simple thing: Give us a prehearing statement on the deadline, and we know you are ready to come and then we get ready for you.
