COG Operating LLC seeks to amend Order R-14055 (1) to reflect the revised pool designated by the Division; (2) to pool the uncommitted interest owners within the WC-025 G-09 S243532M; Wolfbone Pool (98098). Order R-14055 created a 240-acre spacing unit comprised of the W/2 E/2 of Section 29 and the W/2 NE/4 of Section 32, Township 24 South, Range 35 East, NMPM, Lea County, New Mexico, and pooled the mineral interests in the WC-025 G-09 S243532M; Lower Bone Spring Pool underlying said unit. The spacing unit was dedicated to the Viking Helmet State Com No. 2H. Since the entry of Order R-14055, the

Division changed the designated pool for the Viking Helmet State Com No. 2H from the WC-025 G-09 S243532M; Lower Bone Spring Pool to the WC-025 G-09 S243532M; Wolfbone Pool (98098). COG now seeks to amend the Order to reflect the revised pool and to pool the uncommitted interest owners therein.


