STATEMENT OF THE CASE

Applicants seek an order (1) creating a non-standard, 320-acre, more or less, spacing and proration unit comprised of the W/2 W/2 of Section 17 and the W/2 W/2 of Section 20, Township 26 South, Range 28 East, NMPM, Eddy County, New Mexico; and (2) pooling all mineral interests in the Bone Spring formation underlying this acreage.

NEX contends that COG did not have the right to permit or drill the subject well onto NEX's unconsolidated and unpooled lease acreage in the W/2 of Section 20. This case and Case No. 15482 are related to Case No. 15441. Please refer to NEX's Pre-Hearing Statement in Case No. 15441.




