

9. **Case No. 15486:** *Application of Matador Production Company for a non-standard location, Eddy County, New Mexico.* Applicant seeks an order from the Division approving an unorthodox well location for its **Janie Conner 13-24S-28E RB #201H** well located in the N/2 of Section 13, Township 24 South, Range 28 East, N.M.P.M., Eddy County, New Mexico. The Janie Conner 13-24S-28E RB #201H will be horizontally drilled to produce from the Northwest Pierce Crossing-Wolfcamp Gas Pool (Pool Code 96712). The first perforation point for this well will be located 330 feet from the North line and 330 feet from the West line of Section 13, Township 24 South, Range 28 East; and the last perforation point will be located 330 feet from the South line and 330 feet from the East line of Section 13. The Janie Conner 13-24S-28E RB #201H well is located approximately 17 miles southeast of Carlsbad, New Mexico.

Application of Guardian Operating Corporation for Authorization to Inject, Eddy County, New Mexico. Applicant seeks an order authorizing the injection of water for disposal into the Cherry Canyon member of the Delaware Mountain Group formation, Cherry Canyon SWD Pool (97003) in the following well:

Kirkes SWD Well No. 1
2,080' FSL & 1,773' FEL (Unit J)
Section 10
T-24-S, R-28-E, NMPM
Eddy County, New Mexico

Applicant proposes to convert the well at the above location and utilize it for injection of produced water at depths of 3,800' to 4,600' subsurface. The well is located approximately one-half mile North of Malaga, New Mexico.

Application of BTA Oil Producers, LLC for an Order Directing Cimarex Energy Company to Shut-In Its Over-Produced Oil Wells in the Berry; Bone Spring North Pool, Assessing Production Penalties for the Over-Production, and Ordering Compliance with the Division's Oil Proration Rules for the Berry; Bone Spring, North Pool, Lea County, New Mexico. Applicant in the above-styled cause seeks an order (1) directing Cimarex Energy Company of Colorado ("Cimarex") to shut-in its over-produced oil wells completed in the Berry; Bone Spring, North Pool underlying the S/2 S/2 of Section 30, Township 20 South, Range 35 East, NMPM, Lea County, New Mexico; (2) assessing production penalties to curtail future over-production and to compensate for all past over-production from said wells; and (3) directing Cimarex to comply with the Division's oil proration rules for the Berry; Bone Spring North Pool and NMRA 19.15.20.9-12. Said wells are located approximately 16 miles southwest of Monument, New Mexico.
