COG Operating LLC (COG), as Operator, hereby proposes to drill the Fascinator Fee Com #1 well as a horizontal well at the above-captioned location, or at a legal location as approved by the governing regulatory agency, to a TVD of approximately 12,549' and a MD of 19,862' to test the Bone Spring/Wolfcamp Formation(s) ("Operation"). The total cost of the Operation is estimated to be \$12,259,931.00 and a detailed description of the cost is set out in the enclosed Authority for Expenditure ("AFE").

COG is proposing to drill this well under the terms of the modified 1989 AAPL form of Operating Agreement which is enclosed for your review and approval. The Operating Agreement covers Sec 19: SE/4 - T24S-R35E and Sec 30: E/2 - T24S-R35E. It has the following general provisions:

- 100/300 Non-Consenting Penalty
- \$7,000/\$700 Drilling and Producing Rate
- COG Operating LLC named as Operator
