
Re: Case 15293: Application of COG Operating LLC for a non-standard spacing and proration unit and compulsory pooling, Lea County, New Mexico.

Dear Mr. Catanach:

On May 11, 2015, the Oil Conservation Division entered Order No. R-13984 granting the application of COG Operating LLC (COG) in the above-referenced case pooling a non-standard 160-acre oil spacing and proration unit and project area in the North Red Hills-Bone Spring Pool comprised of the E/2 of the W/2 of Section 11, Township 24 South, Range 34 East, NMPM, Lea County, New Mexico. This spacing unit is to be dedicated to the COG Van Gogh Fee Well No. 1H (API No. 30-025-41108). Finding 5 of Order No. R-13984 provides that if COG does not commence drilling the proposed well on or before May 31, 2016, this Order shall be of no effect unless COG obtains a time extension from the Division Director.

Recent economic conditions in the oil and gas industry have forced COG to defer the actual commencement of this well beyond May 31, 2016. While this drilling delay is based on economics, COG intends to drill this well and therefore requests that you extend Order No. R-13984 until May 31, 2017.
