In Case No. 15493, COG seeks an order (1) creating a 160-acre, more or less, spacing and proration unit comprised of the N/2 S/2 of Section 1, Township 19 South, Range 25 East, NMPM, Eddy County, New Mexico; and (2) pooling all mineral interests in the Yeso Formation. This non-standard spacing unit will be the project area for the proposed **Clydesdale 1 Fee No. 5H Well**, which will be horizontally drilled from a surface location in the NE/4 SE/4 (Unit I) to a standard bottom hole location in the NW/4 SW/4 (Unit L) of Section 1.

In Case No. 15494, COG seeks an order (1) creating a 160-acre, more or less, spacing and proration unit comprised of the S/2 S/2 of Section 1, Township 19 South, Range 25 East,

NMPM, Eddy County, New Mexico; and (2) pooling all mineral interests in the Yeso Formation. This non-standard spacing unit will be the project area for COG's proposed **Clydesdale 1 Fee No. 7H Well**, which will be horizontally drilled from a surface location in the SE/4 SE/4 (Unit P) to a standard bottom hole location in the SW/4 SW/4 (Unit M) of Section 1. The completed interval for each of these wells will comply with the Division's setback requirements.


