## APPLICANT'S STATEMENT OF CASE

Matador Production Company ("Matador") seeks to amend Order R-13743 to pool additional uncommitted interest owners in the spacing and proration unit. Division Order R-13743, entered on September 6, 2013, created a 320-acre spacing and proration unit comprised of the N/2 of Section 15, Township 24 South, Range 28 East, NMPM, Eddy County, New Mexico (the "Unit"), and pooled the uncommitted interest owners underlying said Unit in the Wolfcamp formation. The Unit was dedicated to the Ann Com. Well No. 1 (API No. 30-015-23036), which was vertically drilled at a standard gas well location 1,655 feet from the North

line and 1,980 feet from the East line (Unit G) of Section 15 and is producing from the Culebra Bluff; Wolfcamp, South (Gas) Pool (75750). Since the entry of Order R-13743, and in anticipation of drilling an infill well, Matador has discovered additional interest owners. Matador now seeks to amend Order R-13743 to include the additional interest under the terms of the existing pooling order.
