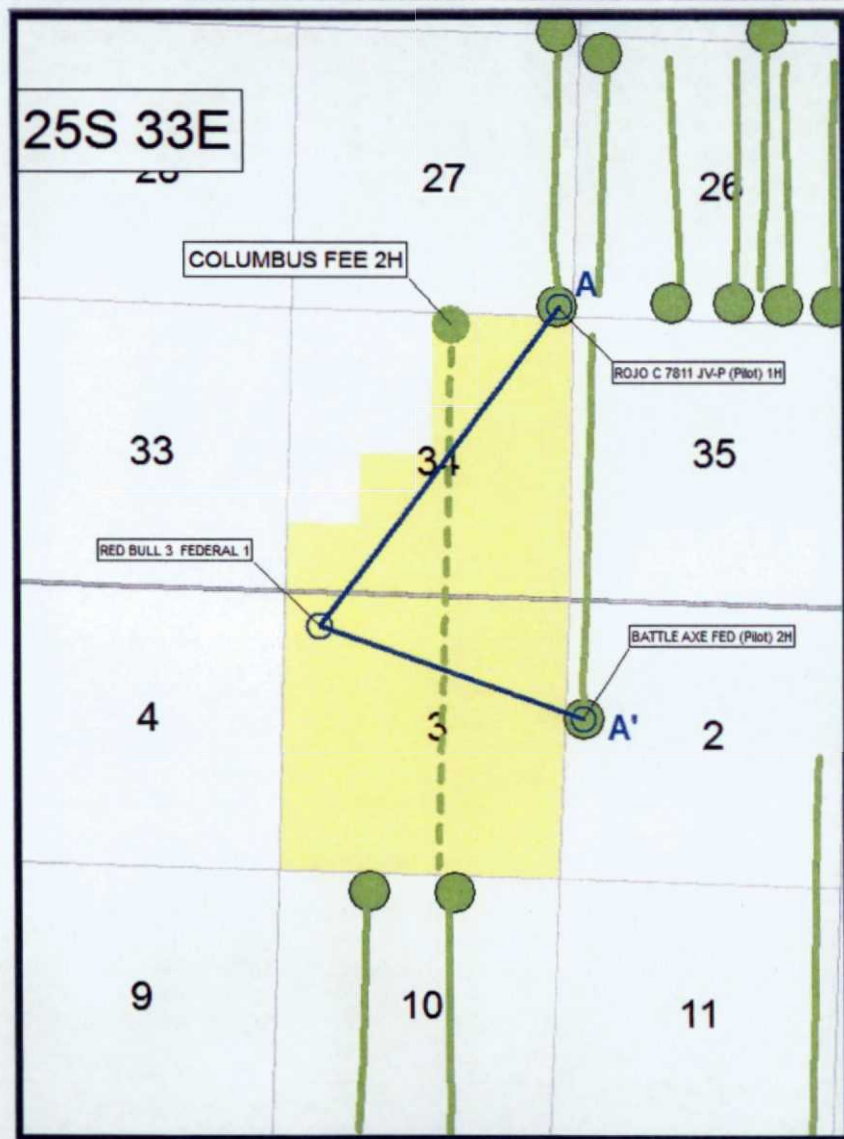

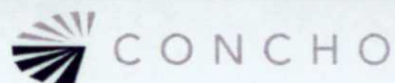

Upper Avalon Cross Section Map



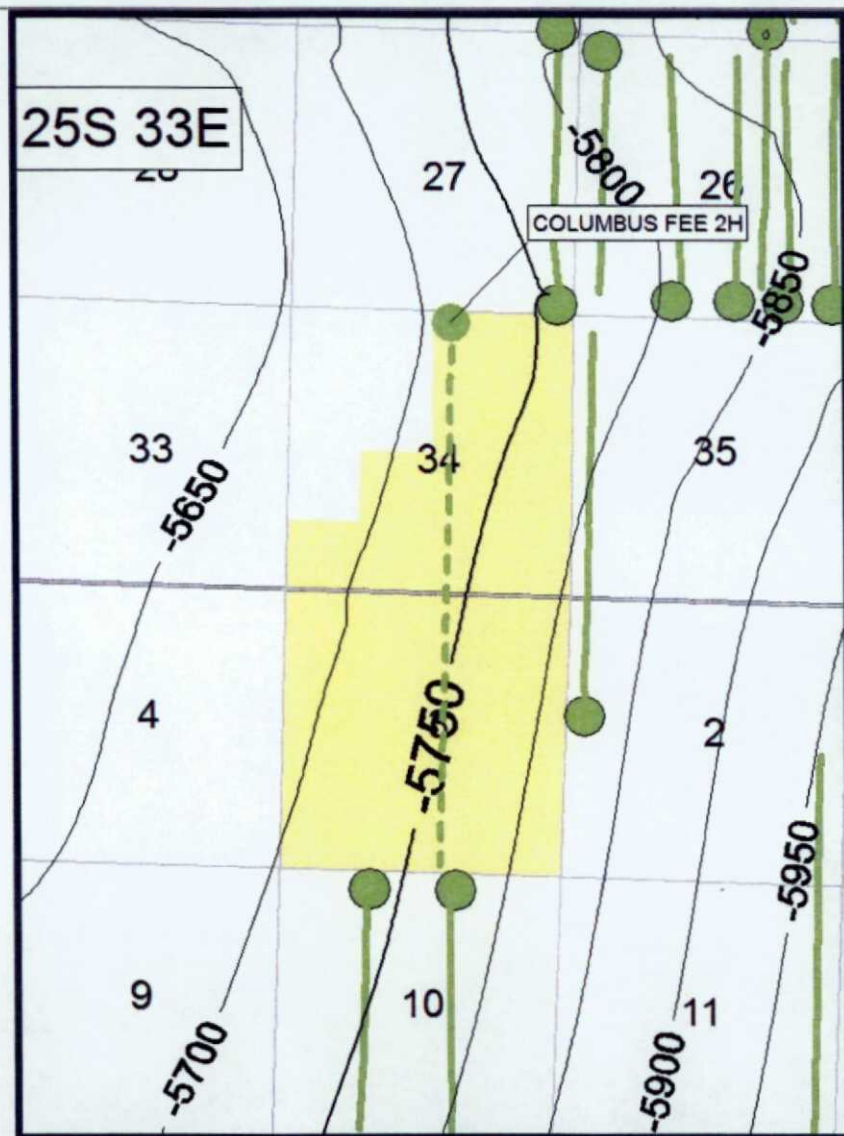

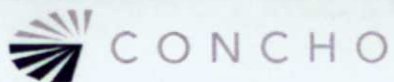

Upper Avalon Upper Avalon Structure Map

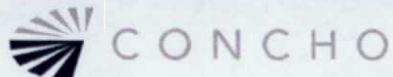
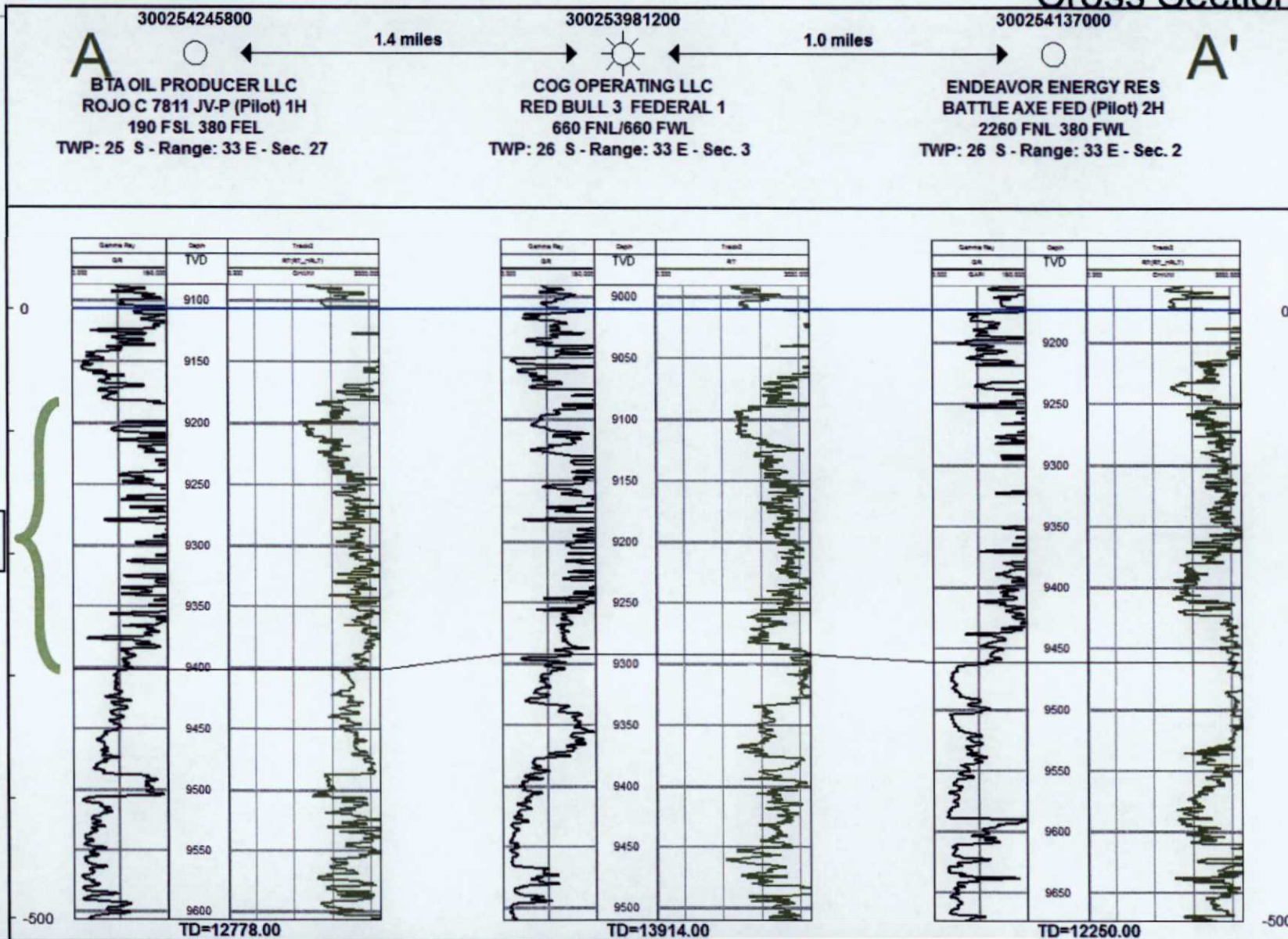
