Mike: Mewbourne originally proposed a JOA covering the entire section from surface to base of Wolfcamp. Black Mountain wanted a JOA covering only the Bone Spring, so Mewbourne sent them a JOA as to the Bone Spring for the full section. The reason is that Black Mountain owns interests in the entire section, and Mewbourne has well proposals out to them on the remaining 480 acres (3 well units) in the section. Black Mountain wants a JOA only on the W/2W/2 in this case, so Mewbourne is sending them one.
