7 Company for a nonstandard spacing and proration unit,
8 compulsory pooling and an unorthodox gas well location,
9 Eddy County, New Mexico.

10 At the same time, I would like to call Case
11 Number 15511, application of Mewbourne Oil Company for a
12 nonstandard spacing and proration unit, compulsory
13 pooling and an unorthodox gas well location, Eddy
14 County, New Mexico.

15 Call for appearances.

16 MR. BRUCE: Mr. Examiner, Jim Bruce of
17 Santa Fe representing the Applicant.

18 EXAMINER McMILLAN: Are there any other
19 appearances?

20 MR. BRUCE: Mr. Examiner, in both of these
21 cases, the case -- the cases have been fully presented.
22 They were continued twice at the request of a third
23 party, who isn't here today, and I'm simply here to ask
24 that the cases be taken under advisement.

25 EXAMINER WADE: Did you hear from the third

1 party?

2 MR. BRUCE: Yeah. It was Joel Carson from
3 Roswell and Ernie Padilla, and their clients and mine
4 are trying to work a deal. But I told them I was going
5 to ask that the cases be taken under advisement.

6 EXAMINER WADE: I'm just curious if we've
7 got anything in our file, if we've heard anything from
8 Mr. Padilla.

9 MR. BRUCE: I can tell you what I will --
10 well, fact of the matter is they've requested three
11 continuances and so have I, so the cases have to be
12 taken under advisement. I'm not going to dismiss them.
13 These cases were too much of a mess in the first place.
14 They did not file a pre-hearing statement. They filed a
15 notice of appearance only.

16 EXAMINER WADE: Just one more question for
17 you. I mean, when they -- did they just -- did they
18 tell you they weren't showing up, they weren't going to
19 make --

20 MR. BRUCE: I talked to Joel Carson
21 yesterday, and I told him I was going to just ask that
22 the cases be taken under advisement.

23 EXAMINER WADE: What you just asked.

24 MR. BRUCE: And he said, I understand.

25 EXAMINER WADE: Is it Joel Carson, or is it

1 Ernie Padilla, or are they working together?

2 MR. BRUCE: Both. They're both.

3 EXAMINER McMILLAN: Okay. We're taking a
4 five-minute break.

5 EXAMINER WADE: What we're going to do is
6 just make sure we didn't receive some kind of email or a
7 fax.

8 MR. BRUCE: Okay. Sure.

9 EXAMINER WADE: That's it.

10 EXAMINER McMILLAN: Okay.

12 EXAMINER McMILLAN: Okay. We are now back
13 on the record.
