**APPLICANT'S STATEMENT OF CASE**

COG Operating LLC seeks an order (1) creating a 223.77-acre, more or less, spacing and proration unit comprised of the E/2 W/2 of Section 28 and the NE/4 NW/4 and Lot 2 of irregular Section 33, Township 26 South, Range 28 East, NMPM, Eddy County, New Mexico; and (2) pooling all uncommitted interests in the Bone Spring Formation. Said non-standard unit is to be dedicated to applicant's proposed **Graham Nash Federal Com No. 7H Well**, which will be horizontally drilled from a surface location in the SE/4 SW/4 (Unit N) of Section 21 to a standard bottom hole location in the SW/4 NW/4 (Lot 2) of irregular Section 33. Section 33 is

an irregular section which border the state of Texas. The completed interval for this well will comply with the Division's setback requirements.




